The Rule

3.9 – Subsidiarity and Freedom of Action The Society embraces the Principle of Subsidiarity as its basic standard of operation. Decisions are made as close as possible to the area of activity to ensure that the local environment and circumstances (cultural, social, political, etc.) are taken into consideration. In this way, the Society promotes local initiatives within its spirit. This freedom of action of Conferences and Councils, which has been kept faithfully since the origins of the Society, enables them to help the poor spontaneously and more effectively, free from excessive bureaucracy. In exercising this freedom of action to face the challenge of poverty in their area, Vincentians feel called to pray together for guidance and strength and for that creative imagination which is the promised gift of the Holy Spirit, "Your old men shall dream dreams and your young men shall see visions" (Joel 3,1). At times, it seems easier to simply dictate to others rather than allow them to make their own decisions. but subsidiarity calls Councils to respect the judgment of Conferences, Conferences of members, and members of neighbors. Subsidiarity, being rooted in respect for the dignity of the human person, is a measure of both justice and charity.

Many conferences write grants to various entities and for various needs. Conferences are under the St. Vincent de Paul Archdiocese of Santa Fe IRS nonprofit status so in order to ensure that these grants follow the Rule of the Society, all grant proposals must be submitted to the ASF Council Board for approval prior to submission to granting entity. Conferences should allow a minimum of two (2) weeks for written ASF Council Board approval. **Policy approved by ASF Council Board on October 27, 2023**


ASF Council Thrift Store

Consumer Financial Protection Bureau

Today, the Consumer Financial Protection Bureau (CFPB) released its annual list of consumer reporting companies. The list identifies dozens of specialty reporting companies that collect and sell access to people's data, including individuals' finances, employment, check writing histories, or rental history

records. People can use the list to, among other things, request their consumer reporting data, dispute inaccuracies, and block access to their credit reporting data through security freezes. The list also informs consumers about the types of personal financial information that is collected for credit and other consumer reports. Included are:

-Consumer reporting companies that share information with casinos,

-Social media, driving data, and other unexpected information can be part of certain consumer reports, -Under many circumstances, people can receive their credit reports for free,

-Hard inquiries can lower credit scores,

Tax Help NM

Do I Qualify? – Single, Head of Household, qualifying Widow(er), Married Filing Jointly **Types of Income** – wages, salaries, tips; scholarships & Pell grants; interest income & tax-exempt interest; dividends; taxable state refunds; self-employment income; stock transactions or capital gains & losses; IRA distributions; pensions & annuities; royalty income; unemployment compensation; SS, SSI or SSDI; veterans income; other such as tribal distributions, jury duty pay & winnings from gambling.

What to bring with you!

In order to have your taxes prepared at a Tax Help New Mexico location, you must have the following documents:

• **Original** Social Security cards or Individual Tax Identification Number (ITIN) for yourself, your spouse and your dependents or anyone else on your return

• Tax payer(s) must have **a current photo ID** (driver license, state issued ID, passport, military ID, tribal ID)

• Birth dates for all persons listed on the return

• Married filing joint: both spouses must be present with proper documentation to complete tax return or power of attorney for absent spouse

In addition to the documents listed above, you must bring any of the following documents that are applicable to your situation: *Income of* \$67,000 or less

• Form 1095-A, B and C (or Health Insurance Exemption Certificate

- All W-2 Forms
- All W-2G Forms (Gambling)

• All 1099 Forms (Miscellaneous, Interest, Dividends, etc.)

- All 1098 Forms (Mortgage and Tuition Statements)
- All K-1 Forms
- Prior year tax return

• Statement from your daycare provider with the amount paid, address and tax number if claiming child and dependent care expenses. If you may be eligible for the state daycare credit, you will need to bring a NM PIT CG from your daycare provider.

• List and total of all itemized deductible expenses such as medical expenses, charitable deductions, real estate taxes, etc.

• List and total of all business expenses, including mileage records, if you are self-employed. Also bring

amounts paid for gross receipts taxes.

- SSA-1099 Social Security benefits statement
- If you are required to repay the first time homebuyer credit, a record of the amount of the credit you received

• If you purchased a home in the last year, bring your closing documents

• Records of all other income received

• If you would like your refund deposited directly into a bank account, bring your bank's routing number and your account number

• If you sold stock we would need purchase date, how much was it purchased for, date sold, how much it was sold for, records of any fees paid

• If you had college educational expenses, bring book and tuition costs.
