January is National Poverty Awareness Month

The United States is considered the richest country in the world, and yet 37.9 million (11.5%) of its residents live in poverty. Poverty is measured in two ways – absolute poverty and relative poverty. Absolute poverty looks at the goods and services someone (or a family) cannot obtain. Relative poverty looks at the context of the need, how one social group compares to others.

Among the most impoverished are:

• Those living in female-headed households with no husband present (23%).

• Young adults without a high school diploma (25.2%).

• Those living in a family whose head of household is unemployed (30%).

• Minorities (19.5% for Black people). The state with the highest poverty rate (based on a three-year average, 2020-22):

1. New Mexico (18.2% of population living below the poverty line)

Am I Really ONLY a Volunteer?

As Vincentians, we call ourselves volunteers. What we should understand is that, yes, we do volunteer our time, talents and treasures, but only within the parameters of a ministry.

Many of our Conferences struggle to find "ministers" for this work. Let's look at what makes a good Vincentian Minister, aka volunteer.

#1 Passion – passion for our organization's values, goals and mission. The first rule of being a minister is – don't commit unless you can complete.

#2 Reliability – a commitment to complete the mundane and not so mundane works on time, with diligence for accurate and precise work and the willingness to learn due to the necessary changes.
#3 Teamwork – working well with others and reaching out when the answers aren't easy to find. Understanding the ministry's culture and why it's necessary for meet the goals and objectives of the work.

#4 Patience – an endless reservoir of patience.
Accepting deadlines, changes, and new ideas.
#5 Creativity – maintain an open-mindedness to build on the current culture for the betterment of the future.

#6 Energetic – Sometimes it's the physical energy, but many times it's the mental and emotional energy that we need to persevere through the exhaustion.
#7 Positive Attitude – leaving our comfort zone to learn new skills and face new challenges. An attitude

of gratitude for the opportunity to change the lives of the less fortunate.

#8 Willingness to Help – stepping up regardless of the task, answering emails promptly, complete training for new endeavors, and not be the grumbler of the group.

#9 Compassion – Volunteering is a selfless gesture; The Golden Rule: practicing the principle of treating others as one wants to be treated. We give our time, our skills and our resources not because we need to, but to give thanks for our many and continued blessings. We make the home visit with a smile after an awful workday. We attend meetings and trainings when other tasks are more exciting. We share our resources because all of us have much more than we truly need.

#10 Organized – being on time, prepared and ready for what is asked of us. Understand time-sensitive issues: assistance to those we serve is provided promptly, filing reports on time, complete and accurate Think of this as a good work ethic to stay motivated and focused and supporting the work and policies.

A lot of the above characteristics of a good minister, aka volunteer, appear to deal with matters that seem to be not at all spiritual. How can this be if our spirituality is the main focus of this ministry? The Society is enabled in our work because we have nonprofit status with all government entities; the IRS when we file our 990, file our 1099s, register with the NM Attorney General's office and complete the annual required audit. All of these filings require paperwork provided on time, valid and truthful and in compliance with their requirements. All of the great work that we as Vincentians do would disappear if we lost this nonprofit status due to noncompliance. Our political spirituality looks at our style of existence and the self-discipline to "repay to Caesar what belongs to Caesar, and to God what belongs to God." Matthew 22:21 Our priorities and values cannot be compromised so we recognize both the secular and religious authorities. Catholic Social Teaching tells us the common good is reached when we work together to improve the well-being of all people. As I was writing this, I noticed some areas that are ripe for improvement in my personal ministry. Maybe some



Tax Help NM

Do I Oualify? – Single, Head of Household, qualifying Widow(er), Married Filing Jointly **Types of Income** – wages, salaries, tips; scholarships & Pell grants; interest income & tax-exempt interest; dividends; taxable state refunds; self-employment income; stock transactions or capital gains & losses; IRA distributions; pensions & annuities; royalty income; unemployment compensation; SS, SSI or SSDI; veterans income; other such as tribal distributions, jury duty pay & winnings from gambling.

What to bring with you!

In order to have your taxes prepared at a Tax Help New Mexico location, you must have the following documents:

• **Original** Social Security cards or Individual Tax Identification Number (ITIN) for yourself, your spouse and your dependents or anyone else on your return

• Tax payer(s) must have a current photo ID (driver license, state issued ID, passport, military ID, tribal ID)

Birth dates for all persons listed on the return

• Married filing joint: both spouses must be present with proper documentation to complete tax return or power of attorney for absent spouse

In addition to the documents listed above, you must bring any of the following documents that are applicable to your situation: *Income of* \$67,000 or less

• Form 1095-A, B and C (or Health Insurance Exemption Certificate

- All W-2 Forms
- All W-2G Forms (Gambling)

• All 1099 Forms (Miscellaneous, Interest, Dividends, etc.)

- All 1098 Forms (Mortgage and Tuition Statements)
- All K-1 Forms
- Prior year tax return

• Statement from your daycare provider with the amount paid, address and tax number if claiming child and dependent care expenses. If you may be eligible for the state daycare credit, you will need to bring a NM PIT CG from your daycare provider.

• List and total of all itemized deductible expenses such as medical expenses, charitable deductions, real estate taxes, etc.

• List and total of all business expenses, including mileage records, if you are self-employed. Also bring

amounts paid for gross receipts taxes.

- SSA-1099 Social Security benefits statement
- If you are required to repay the first time homebuyer credit, a record of the amount of the credit you received

• If you purchased a home in the last year, bring your closing documents

• Records of all other income received

• If you would like your refund deposited directly into a bank account, bring your bank's routing number and your account number

• If you sold stock we would need purchase date, how much was it purchased for, date sold, how much it was sold for, records of any fees paid

• If you had college educational expenses, bring book and tuition costs.
